**Academic Session 2022**

1. The new academic session of the Centre of Education will begin on **Thursday, 16 December 2021**.
2. The audio recording for the individual meditation will be accessible on the school's website: [www.saice.in](http://www.saice.in) by 6:00 a.m.

3. Physical classes will be held as per the timings indicated below:

**Avenir 1, 2, 3; Progrès 1, 2, 3; Cours Accéléré (a):** - From 7:45 a.m. to 11:30 a.m.

Please note that for the above sections, there will be no afternoon classes — physical or online.

Any changes in timings will be communicated at a later date.

**Cours Accéléré (b); EAVP 1, 2, 3, 4, 5, 6; Higher Course 1, 2, 3:**

From 7:45 a.m. to 11:30 a.m. & 1:50 p.m. to 4:00 p.m.

4. The timings for the physical education activities will be communicated by the group captains on 16<sup>th</sup> December 2021.

**Registering the Date of Arrival in Pondicherry**

5. Unvaccinated students will be eligible to start physical classes and physical education activities only if they have:

a) spent at least 14 days in Pondicherry after their date of arrival.

OR

b) Submitted a negative report of an RT-PCR test taken on the 6th day after their return to Pondicherry.

Parents must register the date of arrival of their children in Pondicherry at the Registrar's Office in School promptly if they have not already done so.

6. Students above 18 who have submitted their vaccination certificate don't need to register their date of arrival and follow the 14-day self-isolation or negative RT-PCR test protocol and can join physical classes, group activities and boardings immediately.

**Submission of Consent Form**

7. For all unvaccinated students who will be eligible to start physical classes and group activities on 16<sup>th</sup> December, the parents/guardians should submit a duly-filled hard copy of the parental consent form.
8. Parents should submit the consent form on 15<sup>th</sup> December from 9.30 to 10.30 a.m. at the following locations:

9. All students (vaccinated or unvaccinated) joining the boardings, will also need to submit a duly-filled hard copy of the parental consent form for boardings.

11. **Important:** Students (Avenir 1 to EAVP 6) joining classes after 16<sup>th</sup> December must submit the duly-filled parental consent form at the School Office one day prior to their joining physical classes.
12. Students above 18 do not need to submit a parental consent form.
13. All are reminded to continue to follow Covid-appropriate behaviour.
